The majority of our work involves treatment of mental health/behavioral health concerns: life threatening severe mental illness such as psychosis, schizophrenia and bipolar disorder all forms of addiction; as well as anxiety, depression, divorce or relationship related stress, and other impairing, but highly treatable conditions. We work with consumers in schools, outpatient clinics, homes, jails, facilities serving the elderly, health care settings and residential supported living programs, offering a broad variety of counseling, psychiatric services, case management and emergency consultations.
